The Student Right-to-Know Act is a law passed by Congress in 1990 that requires institutions eligible for Title IV funding under the Higher Education Act of 1965 to disclose the completion or graduation rate of certificate- or degree-seeking, full-time students entering those institutions. The law requires colleges and universities that administer federal Title IV funds to disclose certain information to prospective and enrolled students, parents and employees. The law requires institutions to collect, report, and disclose graduation rates for full-time, first-time, degree-seeking undergraduate students.

<u>Nail Technology</u>: Nail Technologists licensed in the state of Iowa may find employment in beauty salons or nail salons, beauty schools, beauty spas, beauty supply companies and nail product manufacturers, as well as in department store cosmetic counters. Many nail technologists choose to be an independent contractor or own their own nail salon.
